- 3. What do you wish you would have known about college when you began your undergraduate career, and how would you use this insight as an RA?
- 4. If you're a current undergraduate or graduate student, what are your plans after graduation? If you've already graduated, what are your plans for the near future?
- 5. OPTIONAL: Five RAs will be selected as teaching assistants for one of our IN FOCUS seminars in the topic areas of Pre-Law studies, Global Justice/Humanitarianism, Bioethics, Pre-med, or Sustainability. These positions carry additional responsibilities and time commitments for the duration of the two-week seminar. If you would like to be considered for one of these positions, explain why you are interested, and what you feel qualifies you to be a teaching assistant.
- 6. OPTIONAL: One RA will be selected as the Lead RA, which carries additional responsibilities and time commitments for the duration of employment. The Lead RA must be able to be an RA for eight or nine weeks if needed. The Lead RA cannot be an IN FOCUS seminar teaching assistant. If you would like to be considered for this position, please explain why you are interested, and what you feel qualifies you to be the Lead RA.
