- There is a non-refundable registration fee deposit of \$50 and a non-refundable deposit fee of \$250. Please be sure you are committed to taking the class before submitting these deposit fees.
- The full deposit of \$300 must be received by the University before your course enrollment will be processed. You will receive an email from the SPS Registrar's Office within 3-5 business days confirming your registration form has been received and outlining next steps. You should submit your deposit as soon as possible upon receiving the registration confirmation. Once your deposit has been received (which can take 1-2 days), the SPS Registrar's Office will enroll you into your course(es).
