- Official, sealed university transcripts in the language in which they were issued. Each transcript must bear the stamp or seal of the issuing department or faculty.
- Certified English translations of transcripts. Each English language transcript must bear the stamp of the issuing department or faculty. You may not certify your own translation

## **Tuition and Fees**

The 2024-25 full time tuition for Non-degree Special Students is \$22,386/quarter for enrollment in 3 to 5.5 courses (units of credit). Students may also be responsible for applicable student fees.
